Art submission rules

ELIGIBILITY

Youths ages 6 - 17 are eligible to participate. All artwork must be done by hand (or, in the case of physically challenged children, by foot or mouth).

FORMAT & REPRESENTATION

- 11 X 17 inches (Ledger/Tabloid)
- Artwork must NOT be framed or outlined with borders
- Artwork should clearly represent the theme of the contest

MEDIUM

Permitted: acrylic, oil paint, watercolor, indelble marker pens, felt-tip pens, soft ball-point pens, indelible ink, Crayola or any similar indelible medium.

NOT permitted: Non-permanent mediums such as pencil or charcoal; computergenerated artwork; collage work involving the use of photocopies.

MARKINGS

Certificate of authenticity (see reverse) must be attached to the back of the artwork.

The following information must be included on the back of the art:

- first and last name
- mailing address
- · date of birth
- name and address of child's school
