### **Reservation Road Signs:**

Because of the amount of time taking to edit as a group, the decision was made for the members to submit their comments which would be consolidated and forwarded to Tim Penney, Tribal Transportation Coordinator, FHWA.

- Signage Request 1854 Treaty Authority: Mike Moilanen made a motion for MnDOT to revise the specifications to the Reservation Boundary Signs (Reservation Road Sign brochure http://www.dot.state.mn.us/trafficeng/publ/tribalsigningbrochure.pdf) to read "Reservation & Treaty Boundary Signs". Requests for signs must be made be a tribe. Tribe must identify locations of their request. The signs must have uniformity in design. Jim Johnson, motion second. Motion approved.

# MN Tribal-State Relations Training

Linda Aitken and Cindy Bellefeuille provided an update on the training project being developed for all state agency employees who work with tribal issues. A PPT handout was provided as well as a training matrix of the 4 training modules being developed – a 15 hr certification class, a condensed version, topic specific training and tribal government specific training. The 15 hour certification class will be piloted this summer.

# 2013 T&T Conference

John Velat, MI TTAP, via telephone call-in, proposed to the ACTT the opportunity to hold the Tribes & Transportation Conference with the National Tribal Transportation Conference in MN. Variations of the conference were discussed – combined or separate during the same week. Preferred time for conference, by ACTT, is late August or early September at Mystic Lake. The ACTT approved the combined conference.

THE GOAL – "To hire and develop diverse (including those in protected classes; Vets, American Indians, etc...), high-potential trainees, apply individualized training plans, and efficiently produce highly and specifically prepared workers to migrate into HEM/HEFM positions Statewide." Training is on the floor through MnSCU.
