- The NEPA Training is delayed (there is a cost for the delay).
- Limited to 30 participants.
- Funding is an issue.

#### Discussion:

- Art Johnston: Possibility to use Forestry NEPA Training. Would like to attend training because of shared roads/share participation.
- Cheryl Martin: We would like to coordinate this with T&T Conference. What kind of training (NEPA) holistic view beyond general NEPA process. How will tribes view this? Can Bruno/Rick pursue funding.
- Frank Polich: will pursue funding

# Issue: Toward Zero Deaths - draft MN Tribal Road Safety Summit

#### Linda Aitken & Cheryl Martin:

The report was distributed to the ACTT members and a brief discussion was held on the outcomes from the Summit – the Issue of Crash Data Collection that will be worked on by the ACTT and the tribes who have either initiated or will be planning the development of Tribal Strategic Highway Safety Plans. These plans may be used as models for those tribes who want to pursue developing plans in the future.

Linda, along with Chairman Leecy, will present this draft report to the MN Indian Affairs Council when they meet on Tuesday, February 3, 2009 at St. Paul.

The 2009 TZD Conference will be held in October 28 & 29 at the Duluth Entertainment and Convention Center in Duluth, Minnesota.

White Earth held its organizational meeting for developing the White Earth's Strategic Highway Safety Plan on December. They have since had another planning meeting and will follow up with a reservation wide community meeting to provide information to the community members and to seek input for the plan. A meeting to include those who attended the organizational meeting is planned for April to move forward with the information they have gathered from the community.

Cheryl Cloud Westlund: TTAP will feature White Earth's planning in their next newsletter. Wisconsin has been chosen as the next state who will be hosting a Tribal Road Safety Summit.

Cheryl also mentioned the 3M Sign grant: The 3M Sign Grant Program is available to help U.S. government agencies replace underperforming signs with ones made from higher performance prismatic reflective sheeting at significantly lower costs. <u>www.3MSignGrants.com</u>

#### Issue: Crash Data Collection

#### Thomas Martin, Mn/DOT OTSO

Thomas' presentation outlined the type of data Mn/DOT collects, why they collect it, and what value it may have for various reservations if they were to have more accurate information.

#### Discussion:

- Thomas said the GIS product that is available to tribes is the MN BIS Basemap which includes measures and mileage calibrated from the state database of record for roadway inventory. Thomas can get tribes "good numbers" if they are willing to share their shapefiles with Mn/DOT. Currently, White Earth is the only tribe which has provided a GIS map in turn; Mn/DOT has provided back information via the Mn/DOT TDA website. This is an internet based spatial data acquisition site that allows users to download compressed shapefiles for use in their Geographic Information System (GIS), image processing system, or traditional database environment. <a href="http://www.dot.state.mn.us/tda/">http://www.dot.state.mn.us/tda/</a>
- Functional classification correlates and is being updated by Teresa Chapman
- Cad drawings are available via DGNs or paper copies contact Thomas for these.
- Mn/DOT doesn't use AutoCAD. Microstation is the CADD application within the DOT.
- The discussion regarding the difference in number of miles in the reservations networks and that what Frank Polich was talking about certainly would be affected if Mn/DOT were to get data from the reservations regarding their roadway network.

- Tom Fronk said the BIA also requests the shapefiles Carl Hardzinski creates layers in his GIS files.

# **Economic Recovery Program – re IRR**

*Tom Fronk, BIA:* The Economic Recovery Program for the IRR program will be approximately \$300M nationwide/ \$75M to the Midwest Region/ \$25M to Minnesota tribes. The projects must be on the TIP – Federal highway approved plan – currently rushing inventory to Albuquerque. The TIP is approved in Washington. There is a quick turnaround for safety projects.

# Statewide Transportation Plan Update

*Mark Nelson*, Mn/DOT's Statewide Planning Unit Supervisor: Mark provided an update to ACTT on the Minnesota Statewide Transportation Plan for 2009-2028. The plan, titled "Your Destination...Our Priority," sets a long-range vision for transportation in Minnesota and identifies transportation system needs, goals and priorities for the next 20 years. Mark provided a PowerPoint presentation about the plan and also shared the additional opportunities for tribes to review and comment on the plan, including attending one of eight Mn/DOT district stakeholder
