#### Review of ACTT Mission Statement: Linda Aitken, Mn/DOT

The ACTT purpose, mission statement, goals and objectives were reviewed for the benefit of new and old ACTT members, since this had not been done since the Council was organized in

September 2006. Also reviewed was the issues brought to the ACTT which have either been resolved or are still current issues for the Council: Reservation Road Signs; Roadside Vegetation Management; Toward Zero Deaths (Road Safety); and the National Environment Policy Act Training (NEPA).

## **New Business:**

Mn/DOT Civil Rights Office - Update & Discussion: Hope Jensen, Director, Addi Batica, Contract Compliance, and Mike Plumley, Disadvantage Business Enterprise.

Hope Jensen provided an overview of the Civil Rights Office and their proactive goals of expanding the number of DBE contractors on Mn/DOT projects. Issues presented or discussed:

- Tribal Government Summer Institute: A program for 65 70 Jr. High school kids about careers in transportation. Currently programs at tribal colleges Fond du Lac, Leech Lake, Red Lake, and White Earth
- Pilot project at Detroit Lakes to train 10-15 people to get their CDL
- Civil Rights Office seeks stronger relationships with TEROs
- CRO seeks to expand the DBE program throughout the state.
- OJT Fed Mandate program objective is to work minorities/women into journeyman positions. OJT is possible on contracts that are in excess of \$1 million and not less than 100 working days. It also depends on nature of the project needs to be labor intensive. OJT is specified in contract contractors who bid on projects know of this requirement.
- Question is there a location on Mn/DOT's website that TEROs can access to know of projects that include OJT requirements.
- How can Mn/DOT share enough information that TEROs can project skills needed to have workforce prepared
- Mn/DOT is being required of the Legislature to report what Mn/DOT spends on training & success rate.
- DBE goal setting process: Contractors know at time of bid what DBE goals are for project

   at this time it must be good faith effort to comply no punishment/sanction if goals are
   not met.
- Question by ACTT members should this be developed into an issue paper

# Section 106 - Tribal Programmatic Agreements: Cheryl Martin, FHWA

Cheryl presented an overview of FHWA's responsibility under the National Historic Preservation Act, Section 106. Because Mn/DOT is the primary recipient of the Title 23 Federal Aid Highway Funds, FHWA has requested that they provide assistance in complying with NEPA, NHPA and other similar laws. Cheryl explained that to carry out the responsibility of consulting with tribes, FHWA has developed programmatic agreements with several MN tribes, with Mn/DOT as concurring agency. Cheryl also provided a status of programmatic agreement with the tribes.

#### **Old Business:**

**NEPA Workshop:** Issue - Discussion for NEPA Training

Update by Cheryl Martin. The group designated to work on coordinating this training to coincide with the 2009 Tribes & Transportation Conference have not met, but will be meeting prior to the next ACTT meeting. She will invite Jenny Roth, Mn/DOT Environmental Services to the planning team.

Tribal Safety Summits: Update by Cheryl Martin and Linda Aitken

The MN Tribal Road Safety Summit will be held on October 29 and 30 (noon to noon) at the Fortune Bay Casino, Tower, MN. The tribes who were contacted expressed their concern over safety issues on roads on/near their reservations and were supportive of holding the summit. Chairman Kevin Leecy offered to host the meeting at Fortune Bay. A planning committee is being established and requests are being made to tribes for participation on this planning committee.

#### **Toward Zero Death:**

Information was provided regarding the TZD coalitions in Districts 2, 6, and 8. Meetings held have been attended by Leech Lake, Red Lake, White Earth, Lower Sioux and Upper Sioux. Information was also provided about the annual TZD conference on October 7 & 8 at Rochester.

# Roadside Vegetation Management: Discussion by ACTT members

Scott Hanson has been meeting with District 3 staff and is currently working with Mn/DOT Central Office to conduct an inventory of invasive species on Mille Lacs trust land. Fond du Lac and District 1 – Duluth have been working together for a number of years on control of Roadside Vegetation Management and most recently regarding the possibility of "No Chemical Spraying" areas. It is possible the FDL and D1 may take up the Act's issue of developing an MOU for a communications plan and management process.

# IRR BIA Roads Maintenance Reports: Marc Mogan, PIIC

Marc brought the concern to the meeting of the methods used for tracking expenditures for quarterly BIA Roads Maintenance Reports. Discussion centered on not wanting to create a process that was already being used successfully by other tribes. Beth O'Keefe said Lower Sioux had developed a reporting process that could be shared with other tribes.

## **Statewide Transportation Plan:**

Update – The Mn/DOT is currently in the process of updating MN's Statewide Transportation Plan. This two-year process is anticipated to be completed early in 2009. Mn/DOT is seeking input from stakeholders through the face-to-face scheduled outreach sessions Outreach meetings have been and will be scheduled during all phases of the effort -- from <u>sessions</u> in each MnDOT district that were completed in Spring 2007, through a formal review period prior to plan adoption.
