The Minnesota Freight Advisory Committee (MFAC) met September 28, 2006, for its Fall quarterly meeting in Bloomington, Minnesota.

Panel on Education, Training and Safety Programs and Issues for Freight Transportation Professionals/Operators

John Hausladen of the Minnesota Trucking Association (MTA) gave an overview of the driver shortage and its impact on the trucking industry and outlined strategies to recruit new drivers in the areas of: Driver Education; Member Outreach; GetTrucking.com; and specific MTA programs.

Gary Volkman, Dart Transit, outlined the extensive involvement and commitment necessary for an effective and safe driver program. Dart and the trucking industry as a whole have high standards for their drivers with regard to driver qualifications, certification and continuing driver-focused safety programs.
