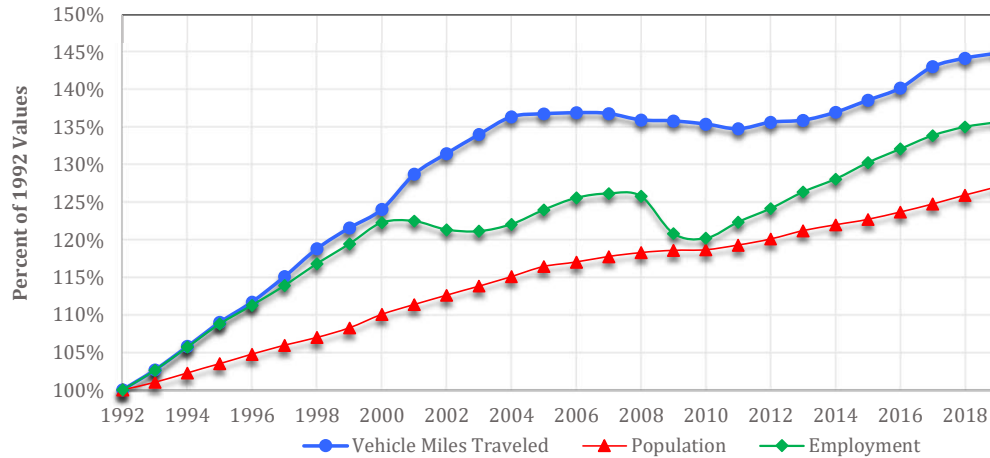
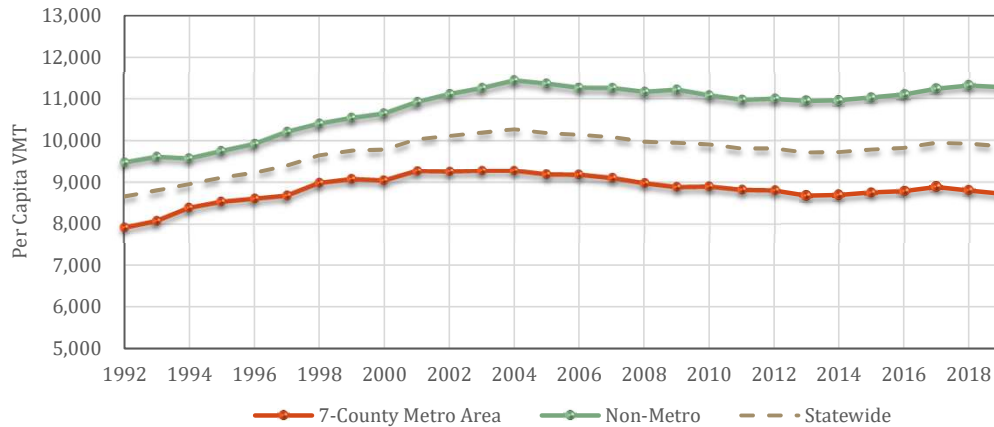

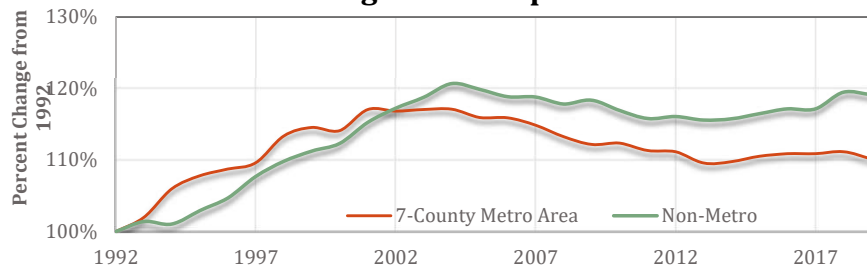
## Statewide Annual Growth Trends:1992-2019
