From 0.7 miles east of Steele County Road 43 (east of Owatonna) and ends at Highway 56 north (west of Dodge Center) at the existing four-lanes.

Request for Letters of Interest for a Design Build Contract

## Greetings,

The Minnesota Department of Transportation – District 6 is soliciting Letters of Interest (LOI) from companies interested in providing Design-Build services for the design and construction of Highway 14 expansion in eastern Steele County and western Dodge County. The proposed construction will include constructing 12.5 miles of four lanes of Highway 14, constructing new interchanges and bridges at Highway 56 and Dodge County Road 3, and constructing new overpasses at Dodge County Road 1, Steele County Road 16 and Canadian Pacific Railway. Project also includes constructing approximately five miles of local roads and the demolition of Bridge 20011. The project has been fully funded and is scheduled for an April of 2019 letting. Approximate cost is \$144 million.

The project procurement schedule is as follows:

- Request for Letters of Interest June 2018
- Reguest For Qualifications release Planned October, 2018
- Submit Statement of Qualifications Planned November, 2018
- Shortlist Teams Planned December, 2018
- Request For Proposals Released Planned Late December, 2018
- Request For Proposals Kick-Off and Disadvantaged Business Enterprise Meet and Greet Planned January 2019
- Contract Letting Planned April 3, 2019
- Construction Planned fall 2019 through fall 2021

The "Best-Value" selection process will be used to evaluate the project consisting of the estimated price of the project divided by the technical score received for the Request for Proposals.
