## NOTE TO BIDDER RESPONSIBILITY OF SUCCESSFUL BIDDER

### WELL, SEWER AND WATER REMOVAL

Any unsealed well(s) found on the site will need to be sealed in accordance with the rules set forth in the current Water Well Construction Code of the Minnesota Department of Health. The abandonment of the existing sewer and water services shall be in conformance with the local and state ordinances, regulations standards. A permit from the local authorities will be needed. Information regarding previously sealed wells and previously abandoned sewer and water services will be available from the Minnesota Department of Transportation.

### EROSION CONTROL AND SEEDING OF SITE

The successful bidder shall install erosion control fence along the perimeter of the property to prevent any surface water from leaving the site potentially impacting the adjacent property, or the roadway. The cost of the erosion control fencing shall be incidental to the building removal.

The successful bidder is responsible for seeding (grass) the site after removal of buildings is complete. To protect the seeded area the successful bidder shall install a wood fiber blanket or approved equal and to restore the entire lot to a well maintainable movable condition, free of rocks, lumps, and excess debris that will inhibit future maintenance by local authorities or the Minnesota Department of Transportation. The site will be inspected and approved prior to the release of the bond.

### LEAD BASED PAINT

Please note that buildings constructed prior to 1978 may contain LEAD BASED PAINT. The EPA & HUD pamphlet entitled "Protect Your Family from Lead in Your Home" will be furnished to the purchaser.

### ASBESTOS AND REGULATED WASTE

Asbestos and regulated materials: The building has been surveyed for the presence of asbestos containing materials and regulated materials; a copy of the survey will be available at the Open House.

Asbestos abatement is required for any asbestos containing materials that may be potentially disturbed during the move in accordance with Minnesota Pollution Control Agency (MPCA) regulations.

Before turning over the building to the successful bidder, Minnesota Department of Transportation will remove all asbestos containing materials and regulated materials that may be potentially disturbed during the move.

Because the basement will not be moved with the structure, all asbestos containing materials and any regulated materials in the basement will be abated/removed by Minnesota Department of Transportation prior to removal of the structure and demolition of the basement.
