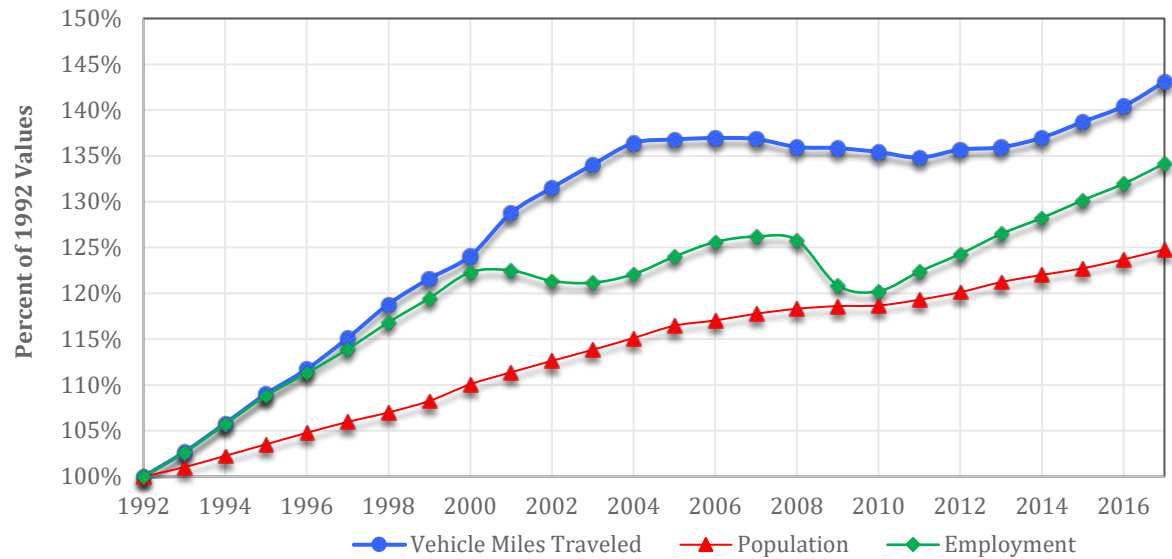
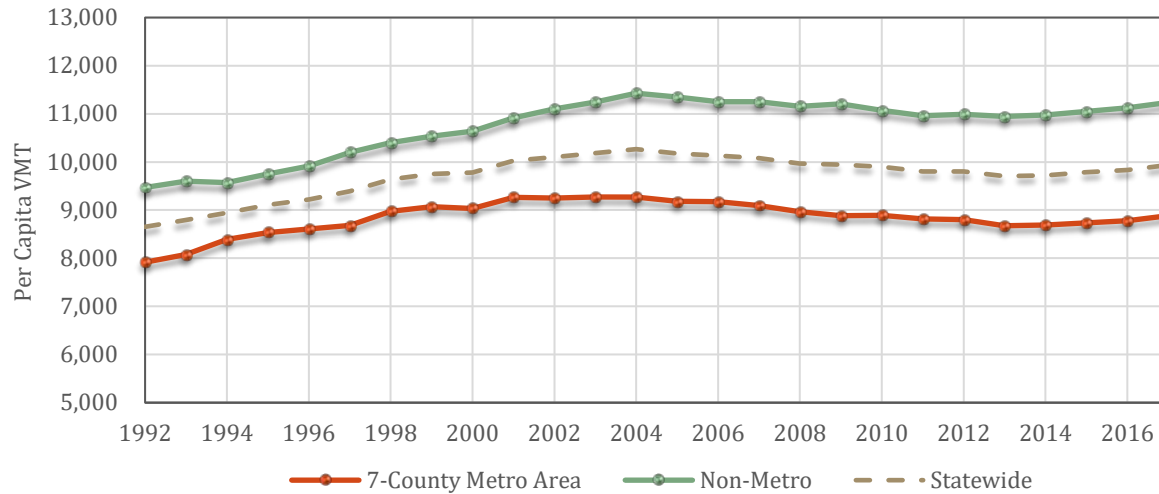

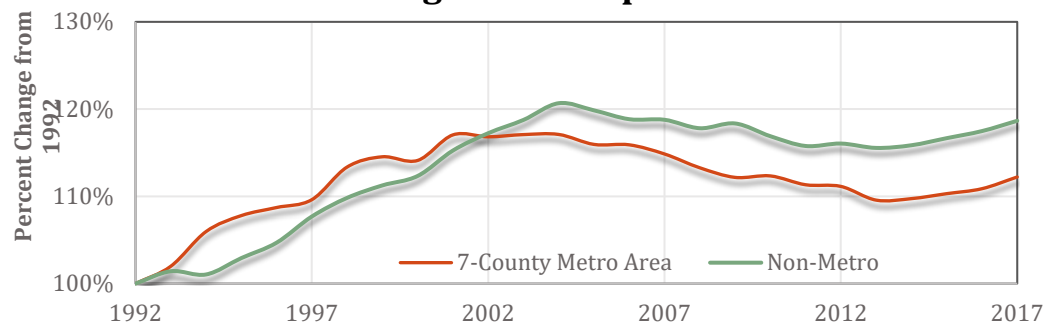
Statewide Annual Growth Trends: 1992-2017
